Filling of Opening: On completion of demolition, the site shall be filled where necessary with clean soil, cinders or other inorganic material and graded to a level not lower than nor more than twelve (12) inches above the level of sidewalks, alleys or adjoining property with proper allowance for settlement.

Debris – Debris caused from the demolition of a building or structure in excess of that required to fill openings as provided in above paragraph shall be removed from the site as wrecking progresses. No salvaged material shall be left on premises.

Penalty – Any person, firm or corporation violating any of the provisions of this ordinance shall be fined not less than twenty-five dollars (\$25) nor more than five hundred dollars (\$500).

I also understand that all work must be completed in compliance with all Village of Dwight Codes and Ordinances as well as any statutes set by the State of Illinois.
